Chartered in 1895, Northern Illinois University (NIU) first opened its doors as the Northern Illinois State Normal School in 1899 as a teachers' school. NIU has grown into a world-class, research-focused public institution that attracts students from across Illinois, the country and the world.

The vision of Northern Illinois University is to be the premier student-centered, research-focused public university in the Midwest, contributing to the advancement of knowledge for the benefit of the people of the region, the state, the nation and the world.

NIU is recognized by the Carnegie Foundation for the Advancement of Teaching in the category of Research Universities (high research activity) and is a member of the Association of Public and Land-grant Universities.

The university and its colleges have institutional membership or other affiliations in or with the American Council on Education, the Association to Advance Collegiate Schools of Business, the Accreditation Board for Engineering and Technology, the National Accrediting Agency for Clinical Laboratory Sciences, and the American Bar Association, among others.

The university is also fully accredited by the National Council for Accreditation of Teacher Education and offers several teacher certification programs, which are approved by the Illinois State Board of Education.
